

Annual Events Help Fund Programs & Services

Every year, thousands of supporters join us for a variety of fun events that impact the health of our communities. We strive to create experiences that inspire, educate and make a lasting impression.

Lend-A-Hand

The Baxter Regional Hospital Foundation hosts several events throughout the year with the theme “Lend-A-Hand, Touch A Life”. This is done to enlist the community’s help to financially support the Mruk Family Education Center on Aging, Peitz Cancer Support House, Reppell Diabetes Learning Center and Schliemann Center for Women’s Health Education.

This year’s Lend-a-Hand campaign in November included a large gift from the Baxter Regional Medical Center Auxiliary, numerous business contributions and a large mailing for Giving Tuesday. In February, the 3rd Annual Masquerade Ball was held. The attendees came dressed in their finest gowns and suits with a wide array of beautiful masks. The evening began with a social hour, red carpet photos, silent auction and photo booth, followed by a delicious dinner. Then at 8:00 pm –

the live performance of Sequel Dose had the crowd on the dance floor until midnight!

BRMC Employee Fund Drive In 2017, our remarkable employees once again rose to the occasion with 84% contributing – pledging a grand total of \$156,000 (1,278 staff members) during the 2017 Employee Fund Drive.

The national average for hospital employees to participate in employee fund drives is 25%. Many of our areas funded (some of which are solely funded by our employees) include the Employee Crisis Fund, Friends Fund, Employee Children and Grandchildren Scholarship Fund, Mountain Home Christian Clinic, Hospice House and the BRMC Community Health Education and Support Houses. In the 17 years of the Employee Fund Drive, BRMC staff members have raised nearly \$1,800,000!



Pink For Peitz Rodeo

The Peitz Cancer Support House, Rand Rodeo Company and Chicks and Spurs drill team hosted the 7th Annual Pink for Peitz Rodeo August 11th & 12th. The Pink for Peitz Rodeo brought enjoyment for the whole family (including 'tug-of-war' competitions, mechanical bull, the 'pink' jail and auctions) while **raising \$33,328 to benefit PCSH programs and services provided to cancer patients and their loved ones.**

Heroes with Halos

After receiving care at BRMC, many of our patients and their families often tell us it is difficult to express the gratitude they feel for the caregivers that touched their life in a special way. **The Heroes with Halos program provides them an avenue to say 'thank you'. When a patient gives a gift in honor of a doctor, nurse, volunteer or any other staff member, they know that their 'Hero' will be acknowledged** in front of their peers by the BRMC President & CEO, Chief Nursing Officer or other member of the Senior Leadership Team. They receive a certificate, special badge holder and their names and photos will be placed in newsletters and social media. In 2017, there were 127 people honored.

Group classes, individual sessions, and ongoing support groups cover topics like healthy eating, being active, monitoring blood levels, taking medication, problem solving, risk reduction, and healthy coping to help successfully manage diabetes. The RDLC also specializes in Insulin Pump Therapy and Continuous Glucose Monitoring.

Diabetes is a very individualized chronic disease that requires special and more personalized therapy. Working with your physician and other members of your health care team, the Certified Diabetes Educators at the Reppell Diabetes Learning Center will provide you with the tools, equipment, and support needed to manage your diabetes.

Approximately 10% of Americans are diagnosed with diabetes and another 86 million people age 20 years and older are diagnosed with pre-diabetes. Type 1, Type 2, Pre-Diabetes and Gestational Diabetes affect more people every year. With proper education and management, diabetes can be well controlled and complications can be avoided.

Various exercise classes include Fit & Fabulous for Women and Fitness for men. Beginning in 2016, we started the Rock Steady Boxing program for Parkinson's patients.

Area physicians lend their expertise on various topics for regular learning sessions and a yearly Men's Health Forum. Additional services at the MFECOIA include the AARP Safe Driving Class, Senior Friendship Connection, resource library, Journey to Healthy Aging and Dr. David Lipschitz seminars.

2017 Major Gifts

Another Year of People Helping People

2017 was another amazing year for the Baxter Regional Hospital Foundation's Major Giving program thanks to the spirit of giving that radiates from the community that surrounds Baxter Regional Medical Center (BRMC). This has a profound impact on our community hospital as it allows BRMC to continue to operate as a comprehensive, community driven and most importantly, independent health care provider. This independence is vital as it ensures the power to make decisions about our hospital remains with the people who know it best—our community.

On June 28, 2017, the Hospital Foundation kicked off the public phase of a \$1 million capital campaign to renovate the BRMC Acute Inpatient Rehabilitation Unit (AIRU). **This unit has been committed to providing the safest environment for physical healing for every patient over the past 20 years.** The AIRU treats a variety of patients from those who have suffered a stroke or another type of neurological disorder to those recovering from an amputation or major trauma to their body.

Although \$1 million was an imposing goal, many generous donors stepped up to the plate to help, including the BRMC Auxiliary, which contributed a lead gift of \$500,000 to the campaign. The therapy gym, where a large portion of a patient's journey to healing takes place, and the dining and recreation area, where patients socialize and perform occupational therapy exercises, were "adopted" by some of our generous donors. The 24 private patient rooms on this

unit were made available to adopt as well. Two of those 24 rooms will become extended stay apartments where patients will have the ability to "test" the self-care skills they have learned in a home-like environment with less AIRU staff supervision.

As of December 31, 2017—\$898,500 has been raised towards the goal of \$1 million for this campaign. What an amazing community!! Work will continue on this campaign until March 31, 2018.

The Susan G. Komen Foundation and the Baxter Regional Hospital Foundation partnered once again marking our 14th year working together to provide uninsured and under-insured women access to free screening mammograms. In 2017, this was expanded to include both the BRMC Mobile Mammography Unit (MMU) and Breast Imaging Center (BIC) and now includes coverage for diagnostic mammograms. Over 4,500 women were helped in 2017, so we are thankful to the Komen Foundation and our many community partners.

The Hospital Foundation also partnered with the State of Arkansas and UAMS and was awarded several grants from these entities which supported areas such as the hospitals' Level 3 Trauma designation and emergency preparedness.

Again, the support from so many donors is what makes this community so special. From our hearts to yours—THANK YOU!
